

**OFFICE**

1. The Registered Office of the Trust will be located at No.1/71. Sriram Nallamani Middle School, Periyapatti Village, Madurai District-625014 a rented Building or at such other Place as the trustees may decide form time to time

**2. AIMS & OBJECTIVES**

The Trust shall be IRREVOABLE. The objects and / or activities of the Trust shall be within India. Subject to the generality of the foregoing the objects of the TRUST shall be:

- i) To establish and / or contribute to educational and cultural Institutions, colleges, schools, libraries, book trusts, reading room and other Institutions and societies.
- ii) To spread knowledge and education by the publication of books, classies and other literature and / or by the establishment of specific endowments or memorials.

- iv) To provide medical relief / to run free medical camps.
- v) To establish construct and maintain hospitals, nursing homes, old age homes, medical colleges, paramedical colleges, wards and institutions for the relief of the sick and to aid and co-operative with other Institutions and societies

doing similar work.

vi) To serve younger generation of this country by means of education in general namely, Arts, Science, Commerce, Industrial, Technical, Catering, Engineering, Professional, Management, Medicine, Yoga or other relative fields, either by way of residential courses or correspondence courses.

vii) To establish, maintain, run, manage, take over, acquire, improve, extend, upgrade or donate, aid and assists in the establishment, maintenance, running, development, improvement and extension of Nursery Schools, Elementary, Middle or Secondary Schools, High Schools, Higher Secondary Schools, colleges of Arts, Fine Arts, Music, Science and Polytechnic, college of Engineering, Medicine, Paramedical, Medical Labs, Business Administration, Industrial Management, Catering Technology, Teacher Training Institutions etc., and generally all kinds of educational Institutions whether general, Industrial, technical, vocational, Professional, residential, correspondence or other description whatsoever for the selfare and uplift of the general public.

ix) To acquire by purchase, gift or otherwise, lands, house sites and building, to greet, build and construct or to aid assist in the erection, construction and building or houses, buildings for educational institutions and colleges, libraries, staff quarters, hostels, and or other type of building or construction whatsoever



- x) To provide for relief for the poor and in particular to help incapacitated persons in poor and destitute circumstances.
- xi) To do all such things as may be conducive or necessary for the advancement of the above objects.
- xii) To make donations to other public charitable Trusts/Institutions recognized under section 80-G of the Income-tax Act,1961.
- xiii) Assistance of hospitals in setting up the various facilities such as Blood Bank, Bye Bank, Burn centers etc.,
- xiv) To render assistance to mentally retarded, crippled and other physically, handicapped children, both directly and through institutions engaged in helping their rehabilitation through appropriate therapy, education, vocational training and other programs.
- xv) To render assistance to orphaned, indigent and other less privileged children for their subsistence, shelter, education and medical care and to establish social welfare institutions engaged in promoting these specific objectives.

- xviii) To render assistance on a case-by-case basis which will, in the opinion of the Trustees, promote the welfare of the deprived members of the community, especially Women and Children, Scheduled tribes and Backward class people.
- xix) To bring about publication that will help promote charity and social service, the income generated if any, from which shall accrue to and form part of the Trust Fund to be utilized for all or any of the objects of the Trust.
- xx) To help and assist other charitable causes of a similar nature as aforesaid as the Trustees may from time to time choose.
- xxi) The Trust shall not carry on any activity of profit or business of any nature.
- xxii) PROVIDED that all such objects shall be those treated as public and charitable and exempt for the purpose of exemption under the provisions of the Indian Income-tax Act, 1961, and / or other Direct Taxes and shall not include application of the funds of the Trust in violation of the provisions of the section 13 of the Income-tax Act, or any other provisions of the said Act and / or any other Act or Acts as may be applicable to Charitable Trusts, the income of which is exempt they now stand and as may be amended from time to time.

### POWER OF TRUSTEES

5. To pay all costs, charges and expenses incidental to the management, administration and execution of the objectives and powers herein contained.
6. To open and maintain account or accounts for the Trust in any scheduled bank or banks for the purpose of keeping the moneys and to operate on the same or to authorize anyone or more to operate upon them.
7. To accept, in cash or kind, donations, gifts, grants, contributions (as Corpus or otherwise) and to collect interest and other income of the Trust for being utilized for furtherance of the aims and objectives of the Trust.
8. To purchase or to take on lease lands, buildings and other immovable or movable properties in the name of the Trust and if necessary to sell the Trust properties for the benefit of the Trust.
9. To invest, dispose of, transfer and otherwise deal with monies, assets and properties, for the time being, of the Trust in such manner as the law permits and proper to do in carrying out objects of the Trust.
10. To pay all expenses preliminary or incidental to the formation of the Trust and its registration and for management and administration for the same.
11. All activities financed from the funds shall be conducted in accordance with the ideals and objects as stated hereinabove and no discrimination should be made on grounds of religion, caste, creed, sex or political affiliation if any the of the implementing agency or beneficiary.

BOARD OF TRUSTEES

12. The Board of Trustees shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think proper, to appoint committee as they may think proper to function under the Authority and control of the Trustees for carrying out objects of the Trust of these presents or the management thereof and invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the objects of Trust.
13. It shall be lawful for the Board of Trustees to settle and determine all matters of interpretation of THESE PRESENTS as well as matters of difficulty, doubt or dispute and all questions arising in the course of time or incidental to the administration, management and execution of the trusts and power of THESE PRESENTS and any such settlement or determination shall be valid, binding and conclusive and shall not be objected to or re-opened upon any ground whatsoever.
14. The Board of Trustees shall have full powers to settle compromise or compound, out of court, all suits, action and other proceedings and to settle all or other proceeding, difference of demand and adjust the settlement of all accounts relating thereto as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasioned thereby.
15. The Board of Trustees shall be entitled to purchase or hire or to take on lease any movable or immovable property or properties for the purpose of carrying out the objects of the Trust hereby created.

16. The Trustees may from time to time, at their discretion for the furtherance and carrying out the objects of the trust of THESE PRESENTS borrow such sum as may be determined by the Board of Trustees from time to time in form and manner thereupon. The Trustee shall, at their discretion, make all such dispositions of the properties movable or immovable forming part of the Trust Fund or any part thereof and enter into such agreements, assurances and things in relation thereto as the Trustees may deem proper for giving security for such loan and interest.
17. All money forming part of the Trust Fund and requiring investment shall be invested in any of the securities authorised by law for investment of Trust Funds which are permissible under section 11(5) of the Income-tax Act, 1961 or shall at their discretion sell and / or realize the same or any part thereof.
18. All money forming part of the Trust Fund requiring investments Shall be invested and the conveyance of assurance in respect of any immovable property / properties forming part of the Trust Fund shall be obtained in the name / names of the Trustees for time being of the Board of Trustees.

**BANK ACCOUNT**

19. The Board of Trustees of the trust may open any bank account or accounts with such scheduled bank as may from time to time be determined by the trustees and shall forthwith pay or cause to be paid the rents, income, dividends and all other money forming part of the Trust Fund to the credit of any such bank account or accounts. The

Trustees shall operate upon the Bank account or accounts or other persons as may from time to time be authorised to do so by a resolution of the Board of Trustees. The Bank account may also be opened in the name of trust or in the name of any institution or projects established by the trust. The Managing Trustee is authorized by the Board to operate the Account of the Trust.

#### ACCONTS & AUDIT

20. The Trustees shall maintain regular Books of account of the trust funds and shall a chartered accountant or firm of chartered accountants duly audit the same. The Accounts and Audit Report of the Trust shall be made-up at least once in a year covering the accounting period as may be determined by the Board of Trustees from time to time.

#### MANAGING TRUSTEE

21. MR.N.NALLAMANI shall be the First Managing Trustee of this trust and shall hold office up to his life time or until the board of Trustees shall choose other as managing trustee or he resigns or if the Board selects an authorised successor.
22. All the trustees who are for the time being and from time in the office shall be referred to collectively as Board of trustees.
23. A trustee must be an individual and no such corporate body such as limited company, firm, society and Trust shall be appointed as a Trustee of the trust.

**POWER TO ALTER RULES AND REGULATIONS**

24. If in the opinion of the Trustees, circumstances so require, the Trustees may unanimously make any amendment in the rules, they may consider necessary for the better management or administration of the Trust activities or for carrying out the objects of the Trust.

25. In addition to the aforesaid rules, the Trustees, shall from time to time, be entitled to make rules and regulations for the administration and management of the Trust of THESE PRESENTS and all matters incidental to or concerning the same PROVIDED, such rules and regulations shall not be repugnant to or be inconsistent with the provisions of the purposes of the Trust thereof.

**AREA OF OPERATION**

26. The area of operation of the activities of "NALLAMANI KONAR EDUCATONAL TRUST" shall be only within India and its Union Territories and not outside India.

**APPLICATION OF INCOME AND TRUST FUND**

27. The Trustee or Trustees shall make investments of the Trust funds in accordance with the provisions of section 11 (5) read with section 13 (1) (d) of the income tax Act, 1961 and rules made there under from time to time.

28. The Accounts of the Trust shall be prepared for the financial year commencing from 1<sup>st</sup> April and ending 31<sup>st</sup> March.

#### AMENDMENT CLAUSE

29. The Trustee or trustees can change the objects of the Trust. The change in any way should not be inconsistent with the basic objects of the Trust and are not repugnant to the provisions of Section 2 (15), 11, 12, 13 and 80G of the Income Tax Act, 1961. The Changes can be done only after getting prior approval from the Commissioner of Income Tax.

#### IRREVOCABILITY

30. It is hereby expressly declared that the trust is a Public Charitable trust and it is irrevocable at any time or under any circumstances.

#### UTILIZATION

31. The Income of the trust shall be utilized for the objects of the trust and no portion of the income of the trust shall be utilized for any other purposes.

#### DISSOLUTION

32. In case of Winding up of the trust, the net funds shall be disposed to such trust or Approved Institution which are having similar objects and enjoying exemptions under section 2 (15), 11, 12, 13, and 80G of the Income Tax Act, 1961.

33. The benefits of the trust shall be open to all irrespective of the caste, creed or religion.

34. The trustees for the time being of THESE PRESENTS, shall be chargeable only for such monies, stocks, funds, deposits and securities as they shall actually receive, notwithstanding their signing of any receipt for the sake of conformity and shall be answerable or accountable only for their own acts, receipts, neglects, defaults, and not for those of others or any banker, auctioneer or any other persons with whom or into whose hands any trust monies or securities may be deposited in accordance with THESE PRESENTS nor for the determination or loss of any stocks, funds, deposits or securities nor for any defects or insufficiency of title nor for any other losses unless the same shall happen through their own neglect or willful demeanor.

35. Proper books of accounts shall be kept by the trustees and the said books of accounts and all letters, documents belonging to the trust shall be kept at the Office of the Trust and at all time open to inspection by the Trustees who shall be entitled to take extracts and copies of the same.

36. The Trustees hereto agree to have bank accounts in the name of the Trust and to raise funds or obtain credits from banks and/or individual and/or anybody by way of deposit, loan, overdraft and shall charge the properties of the Trust for the payment thereof for the purpose of the Trust. The Bank accounts opened in the name of the trust shall be operated by the Founder cum Managing Trustee of the Trust Mr.NALLAMANI individually. The documents relating to the loan agreements shall be executed by Chairman and Managing trustee.
